Information regarding product phaseout EKL PA 0 – 3 EKL GW 0 – 3

Dear Business Partner.

Electro Terminal is constantly striving to keep its product portfolio as up-to-date as possible for the benefit of our customers.

In the products listed below we use brass inserts with max. 4% lead as alloying element. Currently, this use of lead is permitted under exemption 6c of Directive 2011/65/EU (ROHS). An extension of exemption 6c is currently under discussion, but it can be assumed that it will expire in the future. In addition, lead has been included in the REACH candidate list of substances of very high concern.

For this reason, we have decided to phase out the following product groups at the end of 2022, as mentioned in the announcement dated 12-01-2022 – "Price adjustment as of 01-04-2022":

EKL 0 GW & PA EKL 1 GW & PA EKL 2 GW & PA EKL 3 GW & PA

Here you may find details about the product phaseout:

Last orders are possible until 30 September 2022.

From the end of January 2022, only bindingly ordered quantities will be produced. Please note that we can no longer accept forecasts for these items.

New orders will be accepted in reasonable amount.

We will only accept blanket orders in their entirety with the increased prices as of 01-04-2022.

We will supply products until our raw material stock is used up. Depending on the order situation, this may occur before the end of the year. Therefore, we cannot guarantee that all orders can be fulfilled. In this case, you will be informed in the course of order processing.
